

TERMS AND CONDITIONS

Inflatable Disco Package, Hobbs Hill Wood School

Our Terms and Conditions are intended to help you and the children to enjoy an Eazy Peazy Parties event whilst setting out YOUR responsibilities under our hire agreement. From this point you will become The Hirer.

Booking Confirmation

A non-refundable payment of 50% of invoice is required to confirm the booking. This should be paid by cash, cheque or bank transfer. Transfer information can be found on your invoice. Payment of 50% of invoice is ACCEPTANCE OF THESE TERMS AND CONDITIONS.

Booking Cancellation

Eazy Peazy Parties Ltd reserves the right to cancel a booking at any time due to unforeseen circumstances out of our control including adverse weather conditions. In this instance The Hirer will be offered an alternative date subject to availability or receive a refund minus any expenses incurred.

In the event of cancellation by The Hirer within 2 weeks of booking date, no refund will be made and the invoice must be paid in full. If a cancellation is made prior to the final invoice due date no further payment is due. All booking payments are non refundable.

Eazy Peazy Parties Ltd reserves the right to substitute an inflatable or other equipment at any time for a similar piece due to unforeseen circumstances out of our control.

Party Booking at Hobbs Hill Wood Primary School

When booking a package at Hobbs Hill Wood School you are effectively hiring our hall, food hall and our equipment. Child care is not included under any circumstances. It is The Hirer's responsibility to ensure there are sufficient responsible adults to supervise the children. Rules of use are included within this document (Use of Equipment). A member of Eazy Peazy Parties Team will be on site at all times should you need any advice or assistance. The Eazy Peazy Parties staff will spend time in the party hall wherever possible. We reserve the right to intervene if a child's/children's behaviour is deemed dangerous, risks the safety of themselves or other children, or may cause damage to the equipment.

The Hirer is responsible for ensuring their guests are aware of the fire exits and follow the printed fire evacuation procedures displayed in the room upon hearing the fire alarm or in the case of a fire. The Hirer must ensure fire exits remain clear.

The whole of the school premises is a non-smoking area and smoking is not permitted. It is The Hirers responsibility to ensure their guests are aware of this.

The Hirer is able to use the ample parking in the school however cars are parked at owners own risk; and any belonging in the school are left at owners own risk.

Additional children over and above the latest booking form/invoice are chargeable on the day. Additional children are £2.20 per head for the base package and £3 per head for food. If numbers change significantly on the day we cannot guarantee we have enough food/crockery available so please be as accurate as you can when booking. There is no refund available should party goers not arrive on the day.

Party Food

Eazy Peazy Parties will provide food as per the latest information pack. We reserve the right to change items on the menu for a similar item.

We are registered with Dacorum Borough Council as a food business and take food hygiene and safety seriously. It is the responsibility of The Hirer to advise Eazy Peazy Parties of any dietary requests in writing in advance of the booking. Menu substitutions may incur additional charges.

We cannot accommodate nut and other allergies as many of the products we use cannot give us this guarantee. Food Packaging is available on request.

The Hirer will have access to the food hall 30 minutes before the children. You are welcome to bring your own decorations, please secure with blue tac only.

The food hall offers plenty of tables for any necessary preparation. An Eazy Peazy member of staff can provide drinking water if required. The Hirer may not enter the school kitchen under any circumstances. Please do not bring electrical devices.

At the end of your party please ensure tables are clear and ready for cleaning. It is The Hirer's responsibility to clear away ALL rubbish and remove it from the school premises. Eazy Peazy Parties will clean the tables and clean the floor. Please note - If Eazy Peazy Parties are providing the food we will also clear away and remove any food rubbish, however, The Hirer will still be required to clear any other rubbish e.g. decorations.

Use of Equipment

It is the responsibility of The Hirer to ensure that all possible steps are taken to avoid injury or damage to the Inflatables and equipment. All persons using the inflatables do so at their own risk. The person or organisation hiring the equipment will be responsible and liable for any damage or injury occurring from or as a result of misuse or reckless use.

The Hirer is responsible for all injury or damage incurred whilst the equipment is on hire. At the end of your booking, Eazy Peazy Parties will inspect all equipment hired to ensure that it is clean,

unsoiled and that no damage has occurred. The Hirer will be expected to pay an additional charge to cover any cleaning costs and any damage to inflatables, mats or any other Eazy Peazy Parties Equipment. If any equipment is rendered out of use for any reason any loss of earning must be covered by The Hirer.

Please ensure that the following Safety Instructions are followed:

- No food or drinks or chewing gum to be allowed on or near the inflatables which will avoid choking and mess.
- All shoes, glasses, jewellery, badges MUST be removed before using the inflatables.
- All users of our equipment must wear socks and they must remove their shoes to avoid damage and marking. This INCLUDES safety mats and is particularly important when used as a dance area.
- No face paints, party poppers, coloured streamers or silly string to be used in the venue or grounds.
- Under no circumstances are adults allowed to bounce or climb on the inflatables.
- Climbing, hanging or sitting on walls is DANGEROUS and must not be allowed.
- A responsible adult must supervise the inflatables at all times.
- Always ensure that the inflatables are not overcrowded, and limit numbers according to the age and size of children using it (guidelines provided below). Try to avoid large and small children from using it at the same time.
- Children are not pushing, colliding, fighting or behaving in a manner likely to injure or cause distress to others.
- No pets, toys or sharp instruments.
- Do not allow anyone to bounce on the front safety step as a child could easily bounce off the inflatable and get hurt. The step is there to assist users in getting on or off!
- Ensure that no-one with a history of back or neck problems is allowed on the Inflatables as indeed any child who is feeling unwell.
- Do not allow anyone to be on the inflatable during inflation or deflation as this is DANGEROUS.
- Please ensure that children are not attempting somersaults and are clothed appropriately and that nothing can fall out of their pockets.
- In the event that the blower stops working, please ensure all users get off the inflatable immediately and inform an Eazy Peazy Parties staff member straight away.
